LIMITED ENTRY

This event will follow the basic rules of the UpDog Challenge but is not a sanctioned UpDog Challenge event for points.

Facility Information

Indoor Covered Barn with silica/fibre surface – great for dogs! Dogs are not to be allowed to eliminate inside the arena. There are grass areas around the barn to potty your dogs.

Crating area for dogs inside, Bring your own chairs, and a cover for your crate. No x-pens please.

All dogs must be kept in a vehicle, crate, or on leash when not in the ring. Any dog with disruptive behavior (ie. barking, whining, digging) in crating area should be crated in vehicle instead.

There are two portable toilets outside the barn.

There will be coffee/tea provided, but please bring your own snacks or any you'd like to share

Competitor Information

This is a fun match using the basic rules of the UpDog Challenge disc events. Dogs must be at least 6 months of age to enter. Dogs under 12 months of age must keep feet on the ground (no jumping) to catch discs. Rollers are allowed for any dog. For more information about UpDog and the games go to <https://updogchallenge.com> (You do not need to be an official UpDog Team to enter this Fun Match!)

You MUST pick up after yourself and your dog. Anyone found not picking up after themselves or their dog will be excused from the match without a refund. **Do NOT allow your dog to eliminate inside or on the outside of the building!**

Sick dogs/ Bitches in Season: If your dog is sick, please respect the other dogs and DO NOT attend the match and seek veterinary attention. We will offer a refund with a veterinary note, however we will NOT offer a refund to any dogs we need to dismiss from the event site due to illness. Bitches in Season are not permitted to compete. If a bitch comes into season after the entry has been submitted, please withdraw before the closing date for a refund.

Safety shall always be of foremost consideration in actions and conduct by handlers at all times.

Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs. Dogs must remain under control at all times and crated or on leash while on show grounds.

Only 1 dog (the one currently competing) will be off leash at a time. Dogs under 12 months of age must keep feet on the ground (no jumping) when catching discs. Dogs must be able to stay under control off leash during their turn. There will be a fence separating competing dogs from the crating area.

Collars and Leashes: All dogs must wear a flat buckle or snap collar. Harnesses that are fixed (i.e. tracking, seat-belt harnesses) are permitted. We do not recommend dogs wear shoulder-restrictive harnesses while competing. Head halters, martingales, and moving harnesses (such as "no-pull" harnesses) and any harnesses that are designed to be correctional will be allowed outside the ring ONLY. Choke chains, prong or shock collars will NOT be tolerated on show grounds.

An officiating Judge and/or the Chairperson of the match may dismiss from the match site any person in breach of these guidelines or who is subjecting the Judge or members of the organizing committee to abuse, whether that person is competing or not.

If your dog is unable to compete due to a medical condition, we will issue a refund upon receipt of proof from your veterinarian.

GAMES:

Frizgility: A hybrid of disc and agility, this game involves collecting points by taking a series of jumps and tunnels before heading out to catch a disc and doing this as many times as possible within a time limit!

4-way Play: A game involving your dog catching discs in each of the 4 corner areas as many times as possible before time runs out to earn the most points!

Time Warp: A distance and accuracy throwing game where your dog needs to catch one disc at each distance before running back and stopping the time to earn bonus points!
