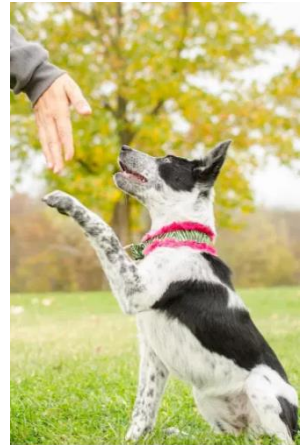
# Workshop Topics:

## **Clear Communication**

Learn how to implement and develop clear communication with your dog for better engagement and trial readiness!

## **Sport Foundation Behaviors**

This seminar focuses on the behaviors needed to develop the concepts for a well-rounded sport dog, no matter what their future holds. During this course, we teach about free-shaping, pivoting, rear end targeting, face targeting, reverse luring and other behaviors.



## **Bombproof Behaviors**

This is a course designed to help teams proof their trial behaviors in a systematic, force free way. Students will learn about how to set their dogs up for success, manage their arousal levels and proof for any distraction. *Teams are required to have behaviours on cue.*

## **Disc Foundations and Skill Building**

We cover a large variety of topics giving the newbie a great foundation to draw from, and advanced teams will also benefit as exercises can be catered to their skill level. Auditors in this section will get to practice throws with the groups.

Sara Brueske has been training dogs for over 15 years, and has experienced a large variety of breeds and sports during that time. Currently, she competes in the sports of disc dog, agility, dock diving, monidoring as well as being a trick dog enthusiast.

Sara believes in positive reinforcement not only for dogs but for their handlers as well. Her biggest joy is watching a handler and dog become partners and grow as a team.

Sara and her dogs demonstrate the sports of disc, agility and dock diving in over 300 dog sports shows for the public each year at the Purina Farms in Grey Summit, MO and they compete nationwide in the US. Having recently re-entered the competition disc world Sara and her dogs earned the titles of 2016 and 2017 UpDog International Freestyle Champion as well as placing on the podium twice with her young Papillion in the 2018 UpDog International Finals.

One unique note about Sara is that she owns dogs from a variety of breeds and origins ranging from a scruffy-faced shelter mix to Belgian Malinois. Currently, she is developing her Australian Koolie breeding program (She is the breeder of Dove's own Koolie Jedi!) and has a special interest in early puppy development and raising puppies for sports.
