Facility Information

LIMITED Air-Conditioned Crating area for dogs inside, first come, first served. Masks mandatory at all times inside the building, including crating area. There are usually shady parking spots outside along East and North side of building. Please keep those shady spots available for people crating in vehicles if you are crating indoors.

All dogs must be kept in a vehicle, crate, or on leash when not in the ring.

Any dog with disruptive behavior (ie. barking, whining, digging) in crating area should be crated in vehicle instead.

There are indoor washrooms inside the building.

Parking is available in our marked DogWorks stalls on the East, North, and a couple on the West side of the building.

There will be separate ring entry and exit doors to keep competitors separate.

COVID Info:

Please do not attend the fun match if you have travelled outside of Canada within the last 14 days or if you have any of the following symptoms: fever, chills, cough, shortness of breath, sore throat.

For the limited crating spaces inside, please ONLY crate in the marked spaces as they are measured out to provide adequate distancing from others.

Competitors ONLY inside the building please. *(If you are bringing more than 1 dog, we allow one human per dog)*

Please maintain at least 6' of space between you and any other person.

Masks will be required at all times inside the building– we will not have extra masks available, so please do not forget to bring one.

Hand sanitizer will be available at main entrances. If you are helping with course building, please make sure to use hand sanitizer right before and after handling equipment.

We are unable to provide a public snack table, but we will have a water cooler for refilling water bottles. Please bring your own water bottle and personal snacks if you wish.

GENERAL AGILITY COMPETITOR INFORMATION

This Fun Match follows AAC rules and regulations, but qualifying rounds will not add to your titles.

As a fun match, toys, treats, collars, and leashes will be permitted.

NO CRUMBLY TREATS!!!

Head halters and shoulder harnesses cannot be worn on course. Choke chains, prong, or shock collars are never permitted at DogWorks events.

Awards: There will be placement awards to the top 3 dogs in each round.

Sick dogs/humans: If you or your dog is sick, please respect the other dogs and DO NOT attend the trial and seek medical attention.

Bitches in season: are not permitted to compete.

You MUST pick up after yourself and your dog. Anyone found not picking up after themselves or their dog will be excused from the event without a refund.

Jumpers: ONLY Jumps + Tunnels

(DogWorks), Happy Dogs Hiking and Raw Food Inc. (HDR). I certify and represent that the dog entered is not a hazard to persons or other dogs.

I agree that DogWorks has the right to refuse this entry for cause, which the organization shall deem to be sufficient.
